MEDIA RELEASE FORM

This form is intended to give consent to take images, moving footage, audio, comments and other personal data to then be stored and used. This form covers consent for use of the above for internal and external communication and storage of the data collected as a result of this consent. All data (images, film, comments, personal info on this form), will be stored by St. Georges' University. The images, moving footage, audio, comments may be shared with University affiliated 3rd party organizations in order to fulfill the communication work necessary, e.g. providing images and other content to design/print agencies, etc.

These rules apply to marketing materials created and/or promoted on behalf of the University. Releases also must be obtained for photographs used on the web. These rules are not in effect when photographs are taken of news events, but photographs taken for news purposes require a release for reuse in marketing materials.

I, the undersigned, do hereby grant to St. George's University, its employees, officers, agents, representatives, trustees, and assigns ("SGU") my permission to interview me and/or to use my comments, likeness in photograph(s)/video in any and all of its publications and in any and all other media, whether now known or hereafter existing, controlled by St. George's University, in perpetuity, and for other use by the University and third party organizations authorized by SGU to use such content. I agree that my image and/or comments may be used for purposes including, but not limited to, editorial content (ie: feature news articles, profiles, testimonials in newsletters, social media posts), marketing collateral (ie: brochures, websites, presentations, signage, emails), and advertisements (ie: print, digital, social).

I agree that neither I nor my heirs shall be entitled to any compensation for the use of my name, photograph, likeness, or other image of myself.

This release applies to photographs, audio, or video recordings, and/or comments collected as part of the session(s) listed on this document only.
